5. **Prerequisite skills-** I acknowledge that I have the skills, qualifications, physical ability to properly and safely use the facilities at The Play Barn.
6. **Waiver-** I hereby waive any protections afforded by any statute or law in any jurisdiction whose purpose and/or effect is to provide that a general release shall not extend to claims, material or otherwise which the person giving the release does not know or suspect to exist at the time of executing the release. I am releasing unknown future claims.
7. **Payment for damages-** I agree to pay for any and all damages to any property or Release party caused by me willfully or otherwise.
8. **Representatives-** I enter into this agreement for myself as well as for my heirs, assigns, and legal representatives.
9. **Insurance-** I understand that I am solely responsible for any medical, health, or personal injury costs relating to my use of The Play Barn and its facilities.
